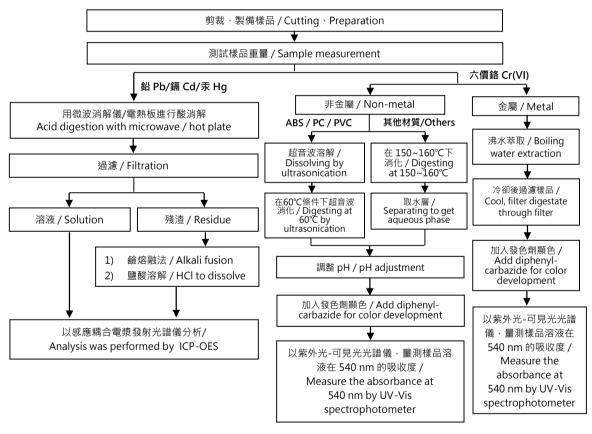

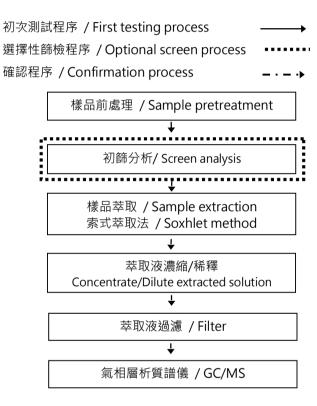

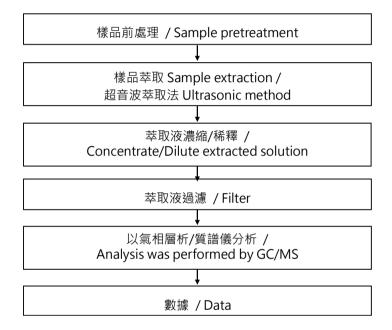

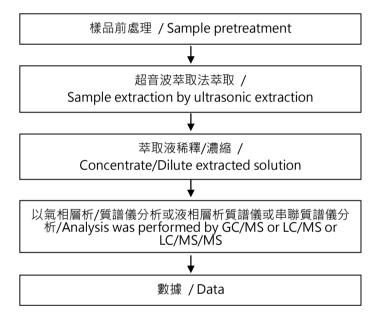

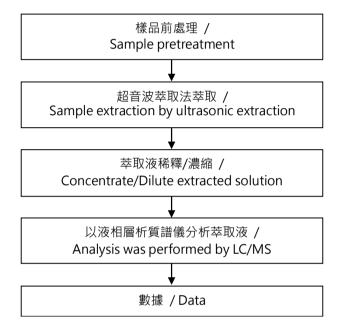

#### 四溴雙酚-A 分析流程圖 / Analytical flow chart - TBBP-A

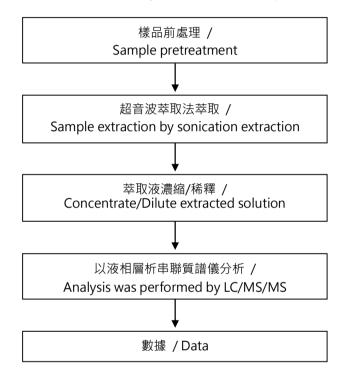

#### 雙酚A分析流程圖 / Analytical flow chart - Bisphenol A

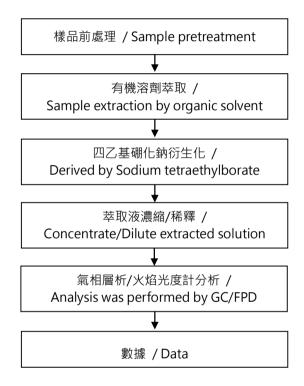

#### 有機錫分析流程圖 / Analytical flow chart - Organic-Tin

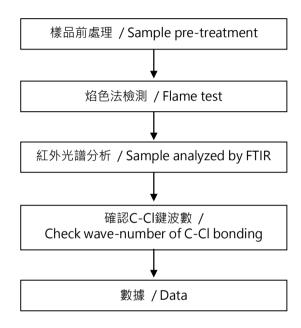

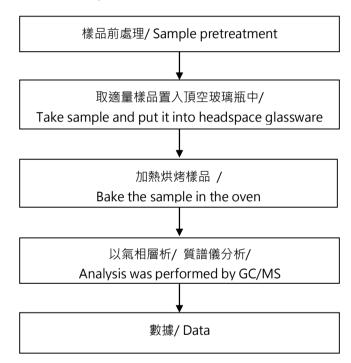
